An initial, non-refundable deposit/payment of \$1,000.00 is required to reserve your hunt. A second payment totaling approximately 50% of the value of the hunt booked, plus WGFD License fees, will be due on or before January 1st, the year of your hunt. The final payment on your hunt will be due in full by August 15th. All reservations made after the WGFD draw will require a 50% deposit/payment at time of booking, with final payment due in full by August 15th. Personal or certified checks, money orders or credit cards are acceptable for all payments to RCO. A transaction fee of 4% will be added to all credit card payments. A Wyoming public lands use fee of \$50.00, and a Wyoming sales and use tax of 10% will be charged on meals and lodging only, and is based on a daily rate of \$100.00 per person, per day. No reservation is confirmed until Rough Country Outfitters and Guides, LLC, has received a full 50% deposit, completed booking contract, liability release and health & dietary questionnaire. All Hunt Reservation Deposits/Payments are non-refundable after January 1st, of the year the hunt is booked for, unless the booked guest can furnish RCO with an acceptable substitute for themselves. Beyond these terms, only upon failure to draw a license will any deposit/payment be returned, within 30 business days of the WGFD on-line drawing results. Withdrawn license applications do not constitute a failure to draw a license. We can make no refunds or adjustments for late arrivals, early departures, no-shows or late hunt cancellations. Likewise, the full contracted hunt fee is the responsibility of the booked client, and owed to the outfitter regardless of the clients participation in his or her booked hunt. Deposit/payments and/or licenses are not transferable to another person.
